

Minutes of the 2/17/09 Meeting

The January meeting of the Lake Housatonic Authority was held at the VRPA offices in the Derby train station.

STANDING COMMITTEES:

Patrol:

John Annino reported that he had received a last minute notice that training would start on February 21st and would continue every Saturday thru March. Mr. Annino suggested sending three candidates for officer training. Two officers were required to fill vacant positions and the third was suggested as training will become very expensive starting next year. He explained the

DEP has made it known that they intend to severe ties with the LHA. They will require the LHA to process its own tickets, subpoenas, etc. The LHA will also have to conduct extensive background checks on all applicants that include DMV check, fingerprints, etc. This will all be done at the LHA's expense. The biggest expense is that after 2009 the LHA will be required to administer drug and psychological tests that could run several hundred dollars. Therefore the board should try to get as many officers trained this year as possible. With the three new recruits and Mr. Annino included, the LHAMP will have a total of 10 officers for 2009. Equipment will be required for two of the three new officers and uniforms will be required for all three.

The board agreed with Mr. Annino's suggestion to train three officers this year. The vice-chairmen requested a motion be made to send the three officers to training as well as hire all ten officers for 2009 season so that training could begin next week. The board agreed and approved a \$1/hour raise for each returning officer as is allotted in the LHAMP guidelines. In addition, Mr. Annino was approved for a one time \$1/hour raise as he had reached the 4 year cap.
