STANDING COMMITTEES:

Patrol:

Mr. Annino presented the working schedule for May and June. He will complete the schedule for the rest of the season by the next meeting. He will be picking up the uniforms over the next two weeks. He reiterated that the DEP was in the process of cutting ties with the LHA and that the LHAMP would be responsible for handling and submitting tickets and associated documents. Minor accidents with no injuries and damages under \$2,000 would also be handled by the LHA unless DEP presence was requested. Sergeant Shaw is now the LHA's DEP liaison operating out of the Derby office, but his involvement will be minimal. An additional officer has been added to the roster, Nick Dibenedet. All officers received a copy of the policy and procedures manuals.

Mike Stahl requested that Mr. Annino make sure that all officers know that the LHAMP boats are only to leave the dock during scheduled patrol times unless authorized by the Board.

Water Quality:

Scott Ames reported the first sample of the season would be taken this week.

Weed Harvester:

Paul Behuniak reported that it is in the water and ready to go.

Vessels and Equipment:

Paul Behuniak reported that the patrol boat had been dropped off last Monday to have the radio serviced. The dump truck was serviced and the boats were cleaned up by John Annino and his crew. A prop will need to be replaced. A spare prop is available.

SPECIAL COMMITTEES:

Regatta Committee

Sandy Blanchard reported that the Sweeps and Sculls regatta would take place Saturday June 6^{th} . He has requested two patrol boats if possible.

OLD BUSINESS:

New LHA Docks

Mike Stahl reported that the new docks have been delivered and assembled. They will be put into the water within the week.
