STANDING COMMITTEES:

Patrol:

John Annino, LHAMP Supervisor, reported that all employment/tax forms were sent to the officers. A blank schedule was also sent to the officers to pencil in their availability for the season. Only five officers have responded so far, even after receiving an extension to respond. Recertification starts on April 18th and we may be at risk of loosing several officers if they can not complete recertification. Mr. Annino stated that the LHAMP would still be adequately manned if the staff was reduced to just the five officers that responded and himself.

Mr. Annino reported that the LHA would not have to undergo the expense of psychological and polygraph tests for LHAMP officers. DEEP has removed the requirement from our agreement.

Mr. Annino requested a motion be made to increase the pay rate for Nicholas Debenedet and Edward Baclawski by \$1/hr in line with their years of service per the LHAMP guide lines.

Motion to increase Nicholas Debenedet and Edward Baclawski pay rates by \$1/hr:

Water Quality:

Scott Ames reported the updated quotes were received. Unfortunately the local lab that was handling the testing since inception will no longer process the samples locally. This will adversely affect the dissolved oxygen test and as such a method of field testing will need to be explored.

Weed Harvester:

Paul Behuniak reported that repairs on the harvester will be completed next week.

Vessels and Equipment:

The radios were reviewed by John Awalt and it was determined that they could be reprogrammed to meet the new narrow banding requirements. He will also begin the process of modifying the license.

Paul Behuniak reported that the docks would be put in the water the weekend of May 11th during the water draw down.

A request was made by John Annino to upgrade the beacon lights to strobe light bars for better visibility and reliability. It was estimated it would cost no more than \$250 per boat.
