Also present was Patrick Kilby, LHAMP Assistant Chief, and Steve Burt, a representative from the New Haven Rowing Club (NHRC).

The Chairman, Mike Stahl, called the meeting to order at 7:30 p.m. and led the group in the pledge of allegiance.

PUBLIC PORTION:

Steve Burt presented an application for marine event on behalf of the NHRC. A permit is being requested for events on 6/8/13 and 10/12/13. The Chairman requested that the NHRC submit their application earlier in the year so as not to create a scheduling conflict. The Chairman explained that the Derby Dam had already submitted for a permit to lower the water to perform repairs and their rain date was 6/8/13. Mr. Burt understood there was a possibility the water may be lowered the day of his event and that LHAMP boats would not be available during low water. This was noted on the application. The application appeared to be in order and the board moved to approve the application with the addition of the low water note.
